  - 4. Based on your experience with similar Master Plan projects, what type of challenges does a project like this represent?
  - 5. How many alternative proposals do you intend to provide to this committee?
  - 6. Please summarize exactly what your deliverables will be to this committee?
  - 7. Will you provide estimated annual costs associated with the Master Plan design?
  - 8. What is your experience dealing with projects with similar topography and what kind of challenges and opportunities does this present?
  - 9. Given your brief overview of this site, what is the biggest need?
  - 10. What is your best estimate of the final cost to develop this Master Plan?
