- Chairman Inderwish opened the meeting at 7:05PM.
- Motion:

- Motion Description: Approve minutes of June 4, 2015 PFC meeting
- Motion Seconded: Mr. Shea
- Motion Discussion:
- Motion Outcome: All approved
 - Mr. D'Ambrosia provided an updated focused on test pit activity at Goodale Park:
 - He was at Goodale Park on July 23 observing test pit activity
 - o A map depicting test pit locations (12 in all) was displayed
 - o Most of the test pits were located in Pine Grove area
 - o Shale was encountered at a depth of approx. three feet in many locations
 - Mr. D'Ambrosia indicated the test pit findings would not result in any recommended changes to the draft Goodale Park Master plans
 - The official written report of test pit results is expected in roughly three weeks (this will delay payment of invoice#5)
 - Discussion then ensued concerning BETA Engineering invoice status with the list below itemizing invoices paid previously (as noted above, invoice#5 remains unpaid):

 - Mr. Inderwish indicated he plans to develop a checklist for the next PFC meeting based on the Goodale Park RFP specifying remaining tasks BETA Engineering is expected to complete.
 - Mr. Flynn inquired if an area for dedication plaques could be designated within Goodale Park (possibly in the area beyond HS Baseball right field) – Mr. D'Ambrosia indicated this request could be accommodated within a final plan.

- Mr. D'Ambrosia pointed out PFC member Mr. Dunne has provided WB Parks permit data covering 2011-2014.
- Discussion then turned to plans for an informational meeting to be hosted by the PFC and attended by BETA Engineering focused on a presentation of the draft Goodale Park Master Plan:
