"The mission of the Community Center Committee is to determine and analyze the needs of West Newbury in regard to an intergenerational Community Center. This Committee will research through various avenues the best way to fill these needs." Motion by Susan Babb, seconded Joel Grossman. All in Favor: Unanimous
