In conformity with the requirements of Section 22 of Chapter 166 of the General Laws (Ter. Ed.), you are hereby notified that a public hearing will be held by the Board of Selectmen of the Town of Winchendon, Massachusetts, on the **8th day of December at 7:00 p.m. in the Winchendon Town Hall, 2nd Floor Auditorium, 109 Front Street**, upon the petition of National Grid for permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

Lakeview Drive:

National Grid to install 1 SO Pole beginning at a point approximately 700 feet South of the centerline of the intersection of Monomonac Road. National Grid to install one SO pole 40-51 to service #76.

Location approximately as shown on plan attached

Also permission to erect and maintain poles and wires, together with such sustaining and protecting fixtures as it may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked

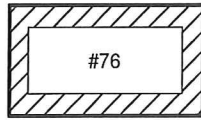

Also for permission to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each of said petitioners may desire for distributing purposes.

Your petitioner agrees to reserve space for one cross-arm at a suitable point on each of said poles for the fire, police, telephone, and telegraph signal wires belonging to the municipality and used by it exclusively for municipal purposes.

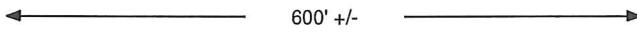

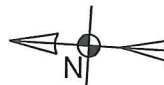
