Chairman Tom Kane called the meeting of the Finance Committee to order at 6:31 p.m.

Acting Chair Ms. Anderson called the meeting of the Board of Selectmen to order at 6:31 p.m.

All stood for the Pledge of Allegiance to the Flag of the United States of America. The meeting aired live on local cable access channel 8

YTD BUDGET TRANSFER:

Chairman Kane spoke of the purpose of the joint meeting to consider the budget transfer requests that are to the extent possible balance out the FY15 budget. The Town Account has been working closely with the Acting Town Manager up the 23rd hour to try and move as much as they can to balance out the accounts. He said they would take through each request one at a time.

Acting Town Manager, Bernie Lynch, commented that there is a very large pile before them that the Town Accountant and her staff and the Finance person he brought with him have been working on. He said its good news considering the bleak financial picture a month and a half ago. Progress has been made in closing things up. What we have before you tonight primarily is that the bills have come in from various departments for July 15th. It is a very tight budget and we are trying to do this without running into any deficits into next year. What is before us is the opportunity to close out deficits so that no ordinary departments have any deficits and the snow and ice deficit has been whittled down to \$19,000. This \$19,000 will be carried over to FY16 which isn't bad given the snow we have had and what we had set aside to start the fiscal year. The only issue we have at this time is to work with the

school department and to try and get information from them and to get their books closed out. They have not provided us with their transfers yet. They have to be in by tomorrow in order to close out the books in a proper way. State law is very clear that they have to be done by the 15th of the month of July. If they are not done then it is probable that those bills that are out there will not be paid because they cannot be paid after that date and they will go into FY16 as unpaid bills and will have to be paid out of FY16 money. We cannot legally and will not run a deficit for FY15. We are still waiting on their June 30th payroll, the transfers to come in but he is happy to say for all the other town departments we have narrowed that down, closed out any of the issues they had and they have snow and ice down to \$19,000 which is pretty remarkable for the Town of Winchendon.
