Approval of Minutes:

Unfinished Business:

154 Mill Street: Mr. White has spoken with Koppleman & Paige. They have assured Mr. White they will get the indemnification. Mr. Glenny is on medical leave for approximately a month. Mr. White expects to get the letter asap.

11 East Street: Still on the market. 2 applications are being processed. They are due on July 27th. The applicants need to be prequalified. Mr. White does not anticipate any action on the property until mid August. As this is a state mandated schedule it is a slow process.

60 Franklin Street: Mr. White has been trying to get ahold of Randall Talansky. Mr. Talansky is Mr. Mugmaw's partner. He has not been able to reach him. WRA would like to speak with Mr. Talansky before legal action is taken. Mr. White will keep trying and invite him to next months meeting.

Bike Path: Mrs. Boucher briefed the board on progress. The last phase is 2.3 miles, the 75% design is complete, and is being reviewed by the engineers. Anticipated construction bid is for January 2013 and construction slated for summer of 2013. This phase is for Glenallen Street to N. Ashburnham Road. This involves the purchase of the Mizhir property. The Town has the funds to purchase with an 80% reimbursement from Federal grants and 20% from Robinson-Broadhurst. The Authority will be running this transaction for the town. *Motion to take land from Town to WRA for bike path Donofrio/LaBrack 5-0 approved @ 3:55 pm.* When Phase 5 is complete there will be a remaining 13 miles to complete.

New Business:

Skate Board Park: Doneen Durling addressed the Authority on the interest on a skate board park on Webster Street. Mrs. Durling has spoken with the residents and local businesses and all have given positive feedback. Mrs. Durling is seeking permission from the Authority to investigate the 7 acre parcel on Webster Street for a possible sight. She is interested in about an acre for the park. She anticipates local help, donations. and volunteers to help with the park.

Motion to allow Mrs. Durling access to Webster Street property LaBrack/Hunt, 5-0 approves @ 4:19 pm.

Ehnstrom Proclamation: Mr. White has the letter done, but can't locate the Ehnstroms. Mr. White will have Proclamation ready for the August Board of Selectman's meeting.
