> MINUTES OF MEETING 7:30 P. M. – November 9, 2011 Joseph Harvey Hearing Room Winthrop Town Hall

CONTINUATION OF THE OCTOBER 12, 2011 PUBLIC HEARING — Town of Winthrop, Ft. Banks Access Road-Representatives: James Lyons, Senior Project Engineer of GEOD Consulting and Steven Calla, Public Works Director. Supplemental information regarding Coastal Bank Boundaries; Complete O&M plan for stormwater/snow removal plan; Complete narrative including a soils & drainage calculations; Geotechnical survey of currently undisturbed land; Geotechnical investigation held October 21, 2011 and Geotechnical report was discussed. Commission asked many questions and received responses from the representatives. Abutters in attendance also had questions. Attorney for the Governors Park Condominium complex, Scott Erickson, had requested lot line delineation for construction and stated that a survey should be done for a lot line clarification.

Chairperson, Mary Kelley, stated that since the supplemental information had not been submitted within the 2-3 week period as standard procedure, but twenty-four (24) hours before this meeting, comment period should be extended to give those who did not have enough time to review the material. Also stated, all comments should be on environmental issues only.
