East of Air

I have a few concerns with Mr. Dubach's plans for his East of Air project.

The first **being in regards to the planting of** Austrian Pine Trees. I was reading up on Austrian Pine Trees and this article was pretty interesting. It said that Austrian Pine Trees can grow to be 90 feet in height, and 15 – 40 feet in width. It also **stated** that this is a very fast growing tree. It does very well in drought and or rain. If I may, I would like to quote the following article I found. It was written by an employee at the Forrest Products Laboratory.

"I grew up with Austrian Pine in Florida and still know very little about it. It grows to 90 feet and sits on a shallow root system that would remind you of a broom stick sitting on a dinner plate. Wind will not only knock one over, but will knock over those that have intertwined the roots. I've seen a roadway that was lined with Austrian pine denuded and the root "balls" formed a 12 foot high wall for the length of the row as all had been blown over.

The wood is quite dense. I have seen it compared with hop horn beam and other woods called ironwood.

This would suspect me to believe that the specific gravity is above 1.0

I've sawed it and it is a difficult wood to mill when green. As a child, I've tried to cut the dry wood with an axe and seen sparks fly.

Once planted as a windbreak in orange groves, it soon became apparent that it was more of a nuisance than a benefit. It's not only an unstable tree, but is invasive as well".

I am not sure this is the **appropriate** tree for what they have in mind. As you are well aware, it is very windy here on the point. If the 90' tree topples...It will topple onto my roof.

My Second concern is that Mr. Duckah is having Mix One Studios (of Boston) design and install a professional sound reinforcement system for East of Air. I did not know what a Reinforcement System was, so I looked it up on Wikipedia. The Answer is:

"A **sound reinforcement system** is the combination of microphones, signal processors, amplifiers, and loudspeakers that makes live or pre-recorded sounds louder and may also distribute those sounds to a larger or more distant audience. In some situations, a sound reinforcement system is also used to enhance the sound of the sources on the stage, as opposed to simply amplifying the sources unaltered. A sound reinforcement system may be very complex, including hundreds of microphones, complex mixing and signal processing systems, tens of thousands of watts of amplification, and multiple loudspeaker arrays, all overseen by a team of audio engineers and technicians".

The reason for my concern is because my 95 year old mother in law lives with us, and she has advanced Alzheimer's. She goes to bed early and I need to ensure that there will not be an excessive amount of noise coming from East of Air. I am sure most of you are aware that persons with Alzheimer's require an abundance of un-interrupted sleep.
