**PUBLIC HEARING** – Boston Gas Co. d/b/a National Grid - Request for Determination of Applicability – Replace natural gas line. **PROJECT LOCATION:** Wave Way. Representative, Marc Bergeron, Vanasse Hangen Brustlin, Worcester, MA. Questions from the Commission answered by Mr. Bergeron. Mr. Bergeron responded to questions asked by abutters.
