MINUTES OF MEETING 7:30 P. M. – March 13, 2013 Joseph Harvey Hearing Room Winthrop Town Hall

<u>Members in Attendance</u>: Mary Kelley, Chairperson, Stephen Machcinski, Norman Hyett, David Girard, Karen Winn, J. Calvin Farrand, Wayne George.

<u>PUBLIC HEARING</u> – Town of Winthrop-DPW – Abbreviated Notice of Intent – Fisherman's Bend Restoration 2013 – Representatives - Steven Calla and Paul O'Donnell, Winthrop Public Works.

Mr. Calla & Mr. O'Donnell explained the details regarding restoration of the trail – remove dead trees & plant new; add guard rails; signage; trash barrels; lot on Sunnyside Ave. to be closed off for parking. Trail will be foot & bike traffic only.

The Commission asked many questions and discussed the list of potential resident volunteers to help maintain this trail. Councilman Mael stated the residents could donate toward this project if they wish for purchase of benches, barrels, etc.

Barbara Duffy, Pico Ave. resident would like Legal Delineation of the property done so all would know what is private and public property. Maureen MacAdams, Seaview Ave. resident also requested a legal delineation.

Residents of the Corinha Beach area are concerned about parking being eliminated. The Commission explained that residents parking on this trail are on Town property. This trailway is under the Care and Custody of the Conservation Commission and No Parking is allowed per State Regulations.

After further questions from residents were answered, the Commission discussed the comments from the Dept. of Environmental Protection regarding the application submittal by the DPW. More information and maps are required. The Commission asked the DPW Director to submit all new plans, etc. This hearing will be continued until the April 10, 2013 hearing date.
