Councilor Sanford, Chairman of the Facilities Committee met with Councilor Calla and Councilor DelVento regarding additional office space within or outside the Town Hall.

The Councilors will meet with the department heads to obtain any ideas they may have then make a recommendation to the Council.

## **NEW BUSINESS**

President Reilly introduced a measure to transfer \$22,000 to a new account for the Council's expenses. The charter provides financial matters should not be acted upon at the meeting it is introduced and referred the matter to the Finance Committee.

President Reilly stated he received a letter from Susan Bolster, Chairman of the Dalrymple Re-Use Study Committee. The committee voted on December 13, 2005 to sell the Dalrymple School. President Reilly referred the matter to the Capital Assets Committee.

Councilor Gill offers a word of thanks to those people who stepped up to offer themselves to the Board of License Commissioners, the Citizen's Advisory Finance Committee and the Board of Health. Councilor Gill looks forward to working with these committees.

President Reilly introduced a measure to create a special committee called the School ADA Compliance Committee for the purpose of studying and making recommendations to the Council of the School Committee at the high school and the middle school including any necessary construction and funding sources. The committee will consist of 2 persons appointed by the Council and 1 appointed by the School Committee. President Reilly referred this matter to the Capital Assets Committee.

Claire Sheltry, Town Clerk Swore-In, Councilor Sanford as Vice President of the Council, Susan Duplin as Clerk of the Council and Robert A. Boncore as a member of the Board of License Commissioners.

Vice President Sanford thanked the Council for their consideration and that it is an honor to be the first Vice President of the Council
