TOWN MANAGER'S REPORT

Town Manager, Richard White reported the rink reconstruction bid exceeded appropriation therefore the bleachers and the dehumidifier will be excluded from the bid. However the May 1, 2007 budget proposal will include an appropriation for the bleachers and a dehumidifier. Demolition is on schedule and expected to be completed October 1, 2007. The Town will have a state of the art rink to be used all year round.

White reported on the April 14th weekend Nor'easter. Mr. White publicly thanked Chief Powers, Captain Flanagan, the Winthrop Police Department and the Department of public works for their strategy and preparedness based on their experience on similar storms responding by making the right choices at the right time. Rick White declared a state of an emergency, documents have been sent to the State He is hoping the State will make a finding giving Winthrop some reimbursement.

White also reported on some construction issues, one being a sewer repair at the Point, estimated cost was \$15,000-\$20,000. There were 2 sinkholes on Otis St. & Maryland Ave with a \$2,000 expenditure. White asked DPW Director, David Hickey to begin to develop a study strategy so that Mr. White can form a proposal on how to manage the sand at Point Shirley.

Councilor Maggio elaborated on all the comments Rick White made about the emergency services in the Town. Emergency preparation is all about beginning the action way before the emergency has to take place. Maggio said 90% of emergency planning is people preparing for themselves and their families.

Vice President Boncore inquired about efforts to restore the streets and manage the sand build up on the Point Shirley beach.

NEW BUSINESS

VOTED: To sell 40 Temple Ave Rear for the bid price of \$35,000.

President Reilly placed before the Council 3 appointments to be voted on at the May 1, 2007 Council meeting. Reilly's recommendations are as follows: Richard Dimes 2yrterm, Planning Board, Peter Roche 3yr-term, Planning Board and Allen E. Maruzzi 3yrterm, Board of Assessors.

President Reilly reported the language for the sale of all alcoholic beverages by restaurants has been referred to Chairman Letterie of the Economic Development Committee to proceed with their disposition of that matter.

President Reilly reported Town Clerk, Claire Sheltry will be retiring early July. The Charter indicates that the Council will elect a Town Clerk with a fixed term of 3 years.

VOTED: To draft a resolution from the Council honoring Beverly Phipps on the occasion of all her work and dedication to the Food Pantry for the Town Winthrop.

Councilor Maggio recognized Bea Farnham who was our Public Health nurse for over 23 years who has retired. She will be sorely missed; she has been a great asset to this community and to the public.

VOICE VOTE:

VOTED: To issue a Council citation to Bea Farnham in thanks for her years of service to the Town of Winthrop.

Councilor Gill stated that it was brought to his attention on a recent WCAT program, there was some fear expressed by a commentator that the council had the potential for collecting health insurance. Gill assures the citizens of Winthrop that the Charter specifically states the councilors shall not be eligible for health benefits.

President Reilly announced the public hearing on the FY08 Budget will be May 15, 2007.

Councilor Calla reported that CASA will be participating in a conference on alcohol advertising on May 3, 2007 at UMASS. CASA Director, Pat Milano reported CASA is working with a number of coalitions across the Commonwealth to ban alcohol advertising in some public places which sends the wrong message to young people.
