Under the provisions of the Home Rule Charter, Section 7-8(a), Town Manager Richard J. White presented to the Council his FY2008 Budget Recommendation. Mr. White's recommendation included expenditures of \$42, 482.412 balanced by a non-tax levy revenues totaling \$23, 164.430 and an estimated tax levy of \$19, 354,460. Tax rate for FY2007 \$9.04 per \$1,000 for residential and for commercial property. Average property tax bill will increase \$80 or 2.5% increase. A comprehensive copy of the FY2008 Budget recommendation is available in the Town Manager's Office, Library, and Town Clerk's Office and on the Town website.
