

Town Council Meeting May 3, 2011

Under the Rules and Procedures of the Winthrop Town Council, President Turco called the meeting to order at 7 PM in the Cummings Multi-purpose Room. All Members were present and the Clerk called the roll.

Minutes

Minutes from April 5 were tabled until they could be completed.

Motion by Councilor Varone, 2nd by Councilor Calla to approve the Minutes of April 26, 2011.

Public Comment

Mr. Stafford spoke on traffic and windmills at Deer Island. Todd Sacco commented on same items.

Committee Reports

Councilor Maggio encouraged the Town to participate in the Health Departments Survey online.

Town Manager's Report

Manager McKenna reported on the following items:

- Hermon Street gas line project
- Deer Island animal control enforcement

He then invited Tara Mizrahi & Adam Berman representing the developer and the engineer on the proposed Temple redevelopment project to give an overview of the plan to build affordable housing along with a new Temple on Shirley Street. Mr Berman stated big picture goals of providing housing, life enrichment services as well as maintaining the Temple. It was explained that this property would need to be put into the Special Development Overlay District and that the matter had been referred to the Planning Board for review. Once the Planning Board submitted a report and recommendation to the Council. The Council would then hold a public hearing on the proposed ordinance change.

Manager McKenna continued to report on the following:

• Winthrop Beach conducted an emergency clean up effort of septic discs after a plant in New Hampshire had been compromised.

• Update on new information from the Federal Census of 2010 recently released and

informed the Council that the information is interesting and can be found on the Town Clerk's web page.

- status on Regional Dispatch E911 Agreement with Revere
- costs of collective bargaining agreements
- year end school bills
