The Town's Attorney Ms. Lane of Koppleman and Paige said there is no penalty if not done but does required it shall be done. Councilor Maggio suggested the appointment vacancy should be made public and tabled until December 6, 2011 meeting.

Motion Passes

Councilor Delvento wants to table although he supports the Town Manager he thinks it's being rushed and it should wait until the new council is in place. Councilor Boncore brought forth a Point of Information stating the Town Managers contract has been on the table for months and only 2 people are changing out of the 9 council members and the council works together. President Turco urged the council to approve the Town Manager's contract stating he has had a positive review, didn't take a raise when his employees didn't receive a raise, took same pay raise as his employees, and 8 out of 9 councilors gave him a glowing recommendation. Regarding making appointments and the changing of the council, President Turco played a three-minute excerpt from a School Committee Meeting of October 2009, a similar situation had taken place and it was agreed to vote although a new board had been elected. Councilor DelVento requested a five minute recess to speak to the Town's Attorney. Councilor DelVento stated he had a few concerns and they were resolved after speaking with the Town's Attorney.

The Town Manager thanked everyone and stated he has a wonderful team of employees. He praised the volunteers for the countless hours they give to the community. He stated he is excited to see new faces and to see President Elect Gill and that he is happy to be able to continue as Town Manager.

There was no objection when President Turco asked to go out of order and take Public Comment before going into Executive Session

PUBLIC COMMENT

Councilor Boncore noted that the applause for Mr. McKenna was the first time in months that people agreed. He also noted that the two candidates in our recent election were complete gentleman and we have got to work together to go forward — CHILL. Councilor Boncore also wanted to thank the people who get involved stating there are

few people who put in for the positions on boards and committees. President Elect Gill thanked Councilor Boncore for his comments and stated he looks forward to working with him.

President Turco made a motion to go to Executive Session to conduct strategy sessions in preparation for negotiations with nonunion personnel or to conduct collective bargaining sessions or contract negotiations with nonunion personnel regarding the Council Clerk 2nd by Boncore
