## **TOWN MANAGER'S REPORT**

## Town Manager James McKenna spoke on:

- **Financial Reporting** Working with the Finance Department to get Dashboard tool to keep track of finances.
- Tax Rate received by DOR -Gerry Perry was impressed with our fiscal performance although some things need to be worked on and addressed.
  - Need to work on our Enterprise Funds and there will be an Enterprise Workshop in the future.
    - Rink operation moving forward, setting rates consistent with users, operating more efficiently and taking care of some previous year liabilities.
    - Recreation vote \$18,000 out of operating budget had to carry forward a minor deficit.
    - <u>Sewer Fund</u> about \$700 short and DOR wants to see us with less hedge in those funds to set our sewer rates.

- <u>Tax Bills</u> went out and abatement forms will be available on-line.
- Environmental Assessment Report from Logan Airport A comprehensive document and we should all take a look at this, it has not been budgeted for professional help in understanding this report but we may want to consider budgeting for a professional. The Manager had questions for the Council (1) Do we want to respond? and (2) How do we respond? The report was about noise, pollution and environment. Airport Hazards Committee should take a look at the report and give advice to the Council and also form a Task Force to respond and be on record.
- Update from DPW Council has been made aware of Contract III a three million dollar project resources from MWRA-SFR Funds and how to make good use of these funds. We will have a presentation with the engineer and DPW Director Calla to the Council to plan a comprehensive strategy. DPW Director Steve Calla reported on bids for Road Way Improvement for the lower Highlands sidewalks and Summit Avenue and Locust Street.
- The Town Manager was happy to report that the Holidays were low key for the Police and Fire and he is pleased with the Leadership in these Departments..
