TOWN MANAGERS REPORT

Planning board has approved Hospital Project. Good investment for our town.

Will be attending Economic Development Summit in Revere. We need to be vigilant on how to encourage commercial development into our town.

Met with engineers on Beach Project and discussed concerns on impact of trucking of sand and how this will affect community. Crest Ave. will be impacted and will work with neighborhood and how to manage parking. DCR are sympathetic and considering opening up storefront/outpost on Crest Ave. where people can address their issues. Will keep council abreast of further meetings.

Making progress with final resolution with Ferry Terminal Building. Meeting last week at building. There is a solution being worked out, should have answers within next 30 days.

Wants Joe Domelowicz talk about Green Communities Grant Application that is ready to be sent to the Department of Energy. Submitted Motion to council for consideration. If awarded can get \$150-\$175 thousand granted to our town for community going green.

Joe Domelowicz proceeds to explain the plusses for the community going ahead with this grant application.

Motion by Vice President Varone to Amend Main Motion (above) would like to raise Town Clerk Salary from \$69,400.00 to \$71,400.00.

2nd. by Councilor DelVento

Discussion: Vice President Varone feels increase necessary since we have lost several valuable employees. Councilor DelVento reads Town Clerk Salaries of other communities as comparison to salary.

Councilor Mael – At committee meeting a tense discussion of not paying as high as other communities but based on amount on money that has been applied in the past, a decision of \$68,584.00 was made at first then decided to raise to \$69,400.00 also discussion that increase would apply now but since a re-review in March was to be done any further increased to should be discussed as there are incoming obligations attached to this position. Does not agree with going to the level of \$71,400.00 as we should wait and see how new skills are being adapted to.

Councilor Calla- She would like Amendment to also include where funds are coming from?

Town Manager agrees that in order to put this salary increase into effect now we have to identify a source of where funds will be drawn.

We need to make motion where funds will be drawn.

When will this salary increase take effect? Retro active to July of this fiscal year or not.

We need motion to know all these answers.

Council President reiterates that Amendment should be made and state where funds coming from and then after that make a transfer. Also add whether it is retroactive.

Councilor Powers- Do we need to have an exact figure as to how much money we are transferring?

Councilor Mael-Are we now introducing retroactive? Council President: No, not yet

Town Manager-Be specific resource funds are from Town Council Reserve Fund

Vice President Varone moves to amend the original motion from the Finance Committee (See Attached Motion)

2nd by Councilor DelVento

Discussion: Councilor Mael asks how much is in Council Reserve? Town Manager McKenna states approx. \$140,000.

Councilor DelVento- 3 positions that the Council itself sets salary on. It should be done annually and it has not been done for 5 years. Wants Council to step up and do on a periodic basis.

Council President states with Councilor DelVento that this has been addressed by a recent change in council rules.

Councilor Letterie-Agrees, but salary from 5 years ago is still up 5.9%. If this amendment passes it will be an additional 11% on top of the 5.95

Councilor Mael- Recommends going back to original motion.

Vice President Varone-Agree, take personality out. What if Town Clerk seeks employment elsewhere we would then have to offer the new Town Clerk the same salary.

Councilor DelVento-Positions has gotten increased but it is still bringing them up to standards. We need to start looking at the position. Duties have been added. We need a pay scale to keep our personnel.
