Finance Committee

Transfer 50% of Free Cash to Stabilization Fund is on hold.

Finance Commission has reviewed the Budget request of the Town Mgr. Councilor Letterie thanks the Finance Commission for their help in this process, especially Bob Wynne.

Bob Wynne then gives the recommendations from the Finance Commission on the Budget. Budget has been accepted with one change: Substitute repairs to the fire station floor for the bobcat. Recommend total budget of \$48,244,381. There are some recommendations that are being brought forward prior to the final vote of the Town Council on the Budget. All recommendations are presented. There is a request on the School Department to submit a monthly/quarterly report of actual to budget and payback. Focus on the future of professional development for all departments should be looked at in the future.

Discussion: Town Mgr.McKenna states most of growth in budget is based on local aid funding. Budget is funded based on revenue, the state is making up the difference of the past 4 years being under funded. This is not the time to begin cutting the budget.

Councilor Letterie agrees with the Town Mgr. at this time, cutting budget at this time is taking a step back.

We have to show the town with the new school vote coming up that the school budget is acceptable. The town budget is more than acceptable with so many line items being involved.

President Gill comments that given the timeframe and diligence of those involved in the budget presentation plus the multiple opportunities for input by the public and Council that, in his opinion, this amendment is inappropriate at the eleventh hour in this process.
