Intensified enforcement of all ordinances with focus on newly adopted Rental Inspection Ordinance and other health and safety related ordinances

Development of a mitigation package with Mohegan Sun /Suffolk Downs should they be granted a casino license by the Massachusetts Gaming Commission

Given the proposed purchase of a new ferry, in addition to commuter service, increase recreational ferry service to include Boston Harbor Island tours.

DevelopWalk Winthrop Project

Continue to improve the annual budget process including budget planning, preparation and monitoring providing for budget stability, sustainability and improvement.

Increased collections of available sources of additional revenue

Aggressive tax title and foreclosure measures as well as Real Estate liens for outstanding water / sewer obligations etc.

Grant seeking efforts – (some grants require matching funds which must be provided for in the annual budget).

Monitoring of fees for services as well as enterprise funds. Fees should cover the cost of service plus reserve

Improved enforcement of all town ordinances. Strengthen inspectional
Services with focus on enforcement of rental inspection ordinance
Adopted in 2013 as well as residential trash and dumpster ordinances
Imposing fines for non-compliance. Stronger enforcement of all

# **TEXT of MOTION**

A motion is made directing the Town Council to discuss the feasibility of making the newly paved parking lots adjacent to the Pond Street Park, The Dalrymple School, The Larsen Rink and the Crest Avenue Parking lot and extension fee paid parking facilities. Included in this new fee would be parking in the George Street lot.

The discussion would be to instruct the Town Manager to create a new parking sticker enabling parking in the lot from 6:00pm-8:00am daily. The automobile must exit the parking lot for snow removal in a reasonable manner. Violators to snow conditions will be subjected to ticketing and towing. Each parking sticker will enable the registered automobile to have a single reserved spot in the lot. The charge will be an annual rate of \$375.00. The rate is in effect from January 1 - December 31 and will be pro-rated by the month. Motorcycles must also be registered for the lot. The space will be leased to the automobile provided all state and local taxes are paid in full. A valid paid Massachusetts automobile excise tax is required but does not have to be issued by the Town of Winthrop.

All money from this parking program will be used to fund a Parks and Recreation Department sponsored program to establish a Khan Academy or other early learning programming. Parental funding will be required for a portion of the programming in line with other Parks and Rec. guidelines. The fund may also be used to fund MCAS, SAT, Character, Wilderness or Parenting programming as deemed valuable by the Superintendent of Schools
