She did not cite any particular case law that has come up in the entire history of the Commonwealth of Massachusetts and I would not feel comfortable subjecting the town to that and if we were to continue on this track I am asking the Town Council to make a motion to the Attorney General's office for an opinion on how to proceed on this matter.

That \$2,800,000 is appropriated for the purpose of financing the replacement of aged water main and lead services in the Cottage Hill surrounding area and Pico Beach surrounding area, including all costs incidental or related there-to; that to meet this appropriation the Treasurer with the approval of the Town Manager is authorized to borrow \$2,800,000 and issue bonds or notes of the Town under Chapter 44 of the General Laws; or any other enabling authority; that the Treasurer with the approval of the Town Manager is authorized to borrow all or a portion of such money from the Massachusetts Water Resources Authority (the "Authority") and in connection therewith to enter into a loan agreement/or financial assistance agreement with the Authority and otherwise to contract with the Authority with respect to such loan and for any grants or aid available for the project or for the financing thereof, which grants and/or aid shall be expended for the project in addition to the amount appropriated and to be borrowed under this order; and that the Town Manager is authorized to acquire by purchase, eminent domain or otherwise, such rights, titles and easements as they may be necessary for such purpose, to abandon such rights, titles and easements as are no longer required, to expend all funds available for the project and to take any other action necessary or convenient to carry out the project.
