### B. Annual Concurrence Emergency Operations Plan

Ms. Silk stated she would like to table this item until the Emergency Management Committee can meet.

Chairman Murray agreed she recalled that such plan should be reviewed by the Committee annually.

<u>Member Sarah Silk moved the Wolfeboro Board of Selectmen to table the request until the Emergency</u> <u>Operation Planning Committee can meet. Dave Senecal seconded. Members voted and being none</u> <u>opposed the motion passed.</u>

# C. Memorandum of Understanding with Friends of Abenaki, Inc. RE: Pop Whalen Arena Fire Protection and Abenaki Snowmaking projects.

Chairman Murray stepped down from discussion.

Ethan Hipple and Bill Swaffield joined the Board for discussion.

Mr. Owen explained that an agreement has been worked out between the town and the Friends of Abenaki, Inc. relative to who is responsible for and to pay for exactly which elements of the Pop Whalen Arena Fire Protection and Abenaki snowmaking projects and such has been submitted for approval.

Ms. Silk noted this is another good example of a public/private endeavor.

<u>Member Chuck Storm moved the Wolfeboro Board of Selectmen to approve and to authorize the Board's Chairman to sign the Memorandum with the Friends of Abenaki, Inc. relative to the Pop Whalen Arena Fire Protection and Abenaki Snowmaking projects. Dave Senecal seconded. Members voted, Linda Murray-abstained and being none opposed the motion passed.</u>

# D. Petition for stop signs at Dimon's Corner Intersection

Charlene Seibel joined the Board for discussion and stated that she and members of her neighborhood are requesting to add some stop signs at the Dimon's Corner Intersection for safety reasons. She read her petition for the record. (See attached) She stated that upon review of this request by the Public Works Director, he not only agrees with the request, but has suggested additional stop signs in the area.

Mr. Owen stated that the Public Works Director has suggested having a meeting with the neighborhood and the Police Department in order to discuss these new stop sign locations and hopes to have that meeting before the next Board meeting for approval.

### <u>Member Chuck Storm moved the Wolfeboro Board of Selectmen to take the matter under advisement until</u> <u>the next Board meeting. Sarah Silk seconded. Members voted and being none opposed the motion passed.</u>

# Old Business

Chairman Murray stated that the Personnel Policy needs updating to include the recent changes from the Union contracts.

Mr. Owen replied he will make those updates.

# Any Other Business

Ms. Silk provided some updates from the Local Government Center regarding HB 457 relative to lowering the interest on late tax payments and that such is opposed by the New Hampshire Municipal Association and SB 133 relative to the taxes on utility poles. Electric companies pay taxes on these poles, but the telephone companies are exempt.

# Town Manager' Report

Mr. Owen stated the following:

- The town website front page has been reorganized and includes streaming meetings.
- The "Extend & Blend" RFP has been put out and is due on April 19<sup>th</sup>. They hope to see a reduction in rates.

- He has received a resignation from a Public Works Department employee effective Friday.
- The 2010 census results have been received and Wolfeboro did see some growth, but the Planning and Development Director does have some concerns with the count and they will continue to review this at a staff level.
- The Public Works Department has put out notice that they will begin sidewalk repairs tomorrow.

### **Committee Reports**

Mr. Senecal stated the Carroll County Transit Committee is expected to have the demand buses available soon and that the on-demand buses have been up and running for three months and are seeing a lot of use.

Ms. Silk stated the following:

- She will be attending another Sharps Committee meeting and hopes to have the brochures available soon for proper disposal of Sharps. She explained that putting them into a hard plastic container and giving them to an attendant is the safe way to dispose of them.
- The Wolfeboro Police Department in conjunction with the DEA will hold a medicine collection on April 30, 2011 at the Public Safety Building. She noted that Household Hazardous Waste disposal collections will start in May and run through October with three medicine collections in June, August, and September (in Alton).

Mr. Storm stated the Planning Board met and finally received the Natural Resource Chapter of the Master Plan.

### Chamber of Commerce

Mary DeVries thanked Chairman Murray on behalf of the Chamber for her service as representative to the Chamber and welcomed Mr. Bowers. She reminded the Board the annual members mingle is April 28, 2011.

### **Questions from the Public**

Suzanne Ryan stated that the Town Report usually lists the names of the delinquent taxpayers and this year's report did not list the names. She noted this is an incentive to get people to pay.

Mr. Owen stated he would have to check into that since that was done in error.
