TOWN OF WOLFEBORO BUDGET COMMITTEE December 18, 2014 Minutes

Members Present: John MacDonald, Chairman, Frank Giebutowski, Vice-Chairman, Dave Senecal, Selectmen's Representative, Harold Parker, Brian Black, Robert Moholland, John Burt, Steve Johnson, Bob Tougher, Members.

Member Absent: Matt Krause, Member (excused).

Staff Present: Dave Owen, Town Manager, Pete Chamberlain, Finance Director, Barry Muccio, Director of Operations, Municipal Electric Department, Dave Ford, Director of Public Works and Water & Sewer Utilities, Lee Ann Keathley, Secretary.

Chairman MacDonald called the meeting to order at 6:03 PM at the Wolfeboro Public Library.

CAPITAL OUTLAY

03-49615-732 Electric Department All-Terrain Vehicle; \$34,000

Barry Muccio stated the 390 line is the sole source of power to Wolfeboro and currently when there is a power failure his staff has to physically patrol the line. He stated once the line is patrolled his workers then have to hike back out to the road to get the necessary equipment and hike back in to fix the line. He stated the workers could patrol the line in one half hour using the all-terrain vehicle and cut down the time of a power outage.

Bob Tougher asked if the machine can carry tools.

Barry Muccio replied yes, noting there is a bed in the back of the vehicle. He stated it would be outfitted with a radio and trailer (distributed specifications of such).

Dave Owen stated the BOS voted 5-0 to support the capital outlay request. He stated the funding for such would come out of the Electric Fund; noting no impact on the tax rate.

Brian Black asked if there is a way to determine whether the issue occurred within the Town's responsibility without walking the entire line.

Barry Muccio stated there are fault indicators on both the Town of Wolfeboro and PSNH's side and noted that standard practice is to physically patrol the line prior to re-energizing.

Brian Black questioned the percentage of line that is typically maintained and accessible by truck.

Barry Muccio stated 3 miles of the line is located in Wolfeboro; noting there are two road crossings/access points however, 99.8% of the line is off road. He stated the vehicle would provide island access as well.

It was moved by John Burt and seconded by Harold Parker to approve the Electric Department Capital Outlay request for an All-Terrain Vehicle, 03-49615-732, in the amount of \$34,000. All members voted in favor. The motion passed.

49612-761 Purchase Chiefs Command Vehicle; \$19,500

Dave Owen stated the BOS voted to purchase the Fire Chief's Command Vehicle out of the Capital Reserve Fund.

John MacDonald questioned whether it will be a lease purchase.

Dave Owen replied no, it would be an outright purchase.

John MacDonald verified the entire purchase would come out of the Capital Reserve Fund.

John Burt stated the Fire Department has a schedule as to when the vehicles will be replaced/purchased. He stated this vehicle will be added to the inventory and there may need to be an increase the annual contribution in order to cover the cost.

Dave Senecal stated the vehicle is not able to pass inspection therefore; a new vehicle is required and will be purchased using the funds in the capital reserve account.

It was moved by Bob Moholland and seconded by Harold Parker to decrease 49612-761 from \$19,500 to \$0. Bob Moholland, John MacDonald, Harold Parker, Bob Tougher, Frank Giebutowski, Brian Black, Steve Johnson voted in favor. John Burt opposed. The motion passed.

01-49613-731 Railroad Station Playground; \$18,900

Dave Owen distributed the letter of support for such from the EDC and noted the cost for the project was decreased from \$20,917 to \$18,476 due to the Public Works Department doing the sitework. He stated the nursery school is contributing \$18,894.

John Burt asked if the school would be paying the insurance.

Dave Owen stated the Town would be taking over such.

John Burt questioned the cost of such.

Dave Owen stated the cost would be minimal and the playground would be added to the list of other Town playgrounds.

It was moved by Harold Parker and seconded by Brian Black to increase 01-49613-731 Railroad Station Playground from \$0 to \$18,900. All members voted in favor. The motion passed.

01-49606-710 Middleton Road Cemetery; \$28,708

Dave Owen stated the project has been tabled to 2016.

Frank Giebutowski questioned the cost savings of doing the project in 2015 following the completion of the Middleton Road upgrades and using the same contractor for the cemetery project.

Dave Owen stated the cost of the project would be reduced by \$26,250.

It was moved by Bob Tougher and seconded by Bob Moholland to decrease 01-49606-710 from \$28,708 to \$0. All members voted in favor. The motion passed.

AGENCIES

End 68 Hours of Hunger

Dave Owen stated End 68 Hours of Hunger is a new agency request.

Claire Donahue stated the organization is a 501C3 and is requesting \$3,000; noting school children pre-school to 6th grade are served. She stated children leave school on Friday afternoon and will have little or no food to eat over the weekend (68 hours that children are not in school). She stated the Wolfeboro Chapter served 11 children this past week (3 bags to Crescent Lake School and 8 bags to Carpenter School) and noted Huggins Hospital provides two rooms for food storage. She stated the Towns of Ossipee (\$4,000) and Tuftonboro (\$2,000) approved their funding request. She stated all the money goes towards food; noting the organization is run by volunteers. She stated the cost per bag of food is \$10 for 40 weeks.

Sarah Silk stated the BOS approved the request 5-0.

John MacDonald asked if the organization interfaces with the Food Pantry.

Claire Donahue replied no, the Food Pantry is a separate entity.

It was moved by Harold Parker and seconded by Frank Giebutowski to approve the End 68 Hours of Hunger funding request, 01-44181-830, in the amount of \$3,000. All members voted in favor. The motion passed.

Frank Giebutowski questioned the Sewer Ordinance update.

Dave Ford stated the current ordinance is out of date and needs to be updated.

Public Works Capital Outlay

01-49613-736

BMPs Lake Wentworth; \$15,000

Dave Ford stated the Lake Wentworth Watershed Management Plan calls for BMPs to help reduce pollutant loads on the lake and preserve the long term water quality. He stated the proposed projects include the area between Genes Beach and the State Beach on Route 109 and repairing a major road drainage problem from South Main Street to Crescent Lake. He stated the funds would be matched by 319 Grants at 60/40.

01-49615-762 DPW Document Storage Room; \$20,000

Dave Ford stated he proposes a document storage room located above the office space in the new garage. He stated the department has thousands of plans, files and documents related to the Town's infrastructure. He stated he originally requested \$40,000 however the BOS reduced the amount to \$20,000 and phased the project. He stated he hopes to reduce the cost by doing the carpentry in house.

John Burt disagreed with phasing the project and recommended increasing the request to \$40,000 since \$19,500 was removed from the Fire Department.

<u>It was moved by John Burt and seconded by Harold Parker to increase 01-49615-762 DPW Document Storage Room from \$20,000 to \$40,000.</u>

Discussion of the motion:

John MacDonald asked if the project could be put off another year given other project requests.

Dave Ford replied yes and noted he could get the construction detail, price and bid document for next year.

John Burt withdrew his motion. Harold Parker withdrew his second.

It was moved by John Burt and seconded by Harold Parker to decrease 01-49615-762 DPW Document Storage Room from \$20,000 to \$0. All members voted in favor. The motion passed.

Water Fund Capital Outlay

02-49613-730 WS-3 Water Department Crew Truck; \$30,000

Dave Ford stated WS-3 was scheduled for replacement last year however, the request was cut by the Budget Committee. He stated the truck would be used by the Water and Sewer Foreman and would be an extended cab ½ ton pickup truck. He stated the current truck is a 2003 ¾ ton truck.

02-49615-761 Grove Street Water Main Replacement; \$90,000

Dave Ford stated the project would include the replacement of all water distribution infrastructure on Grove Street and Whitten Neck Road. He stated Grove Street currently has a two inch plastic water main with no fire hydrant at the end; noting the proposed project includes the installation of a new 6 inch ductile iron main, replace all old service lines, valves, service/in-line valve boxes and install a new fire hydrant. He stated Whitten Neck Road currently has a 6 inch cast iron water main installed in 1971 and the proposed project includes the design of a new 6 inch ductile iron main, replace all old service lines, valves, service/inline valve boxes and replace two existing fire hydrants.

WARRANT ARTICLES

Article D Town Road Upgrades; \$650,000

Dave Ford noted the following road improvements for 2015; Beach Pond Road (SW to Northline Road), Beach Pond Road (Route 109A to Furber Lane), Grove Street, Port Wedeln, Winterhaven Road and Old Lakeview Terrace.

Article E Construction of Stonehenge Road Subject to Betterment Assessments; \$80,000

Dave Ford stated the Town received a petition to lay out, design and construct Stonehenge Road to Town standards; noting the residents of the road are in agreement to pay for the upgrade subject to betterment assessments.

Article F Sidewalk Upgrades; \$100,000

Dave Ford stated the sidewalk upgrades include the following; sidewalk from the high school to Treadwell Lane including curbing (to be done spring 2015) and sidewalk and drainage improvements on South Main Street to Middleton Road.

Article H Abenaki Four-Season Lodge Capital Reserve Account; \$281,135

Ethan Hipple reviewed the PowerPoint presentation, see attached.

Bill Swaffield stated the Friends of Abenaki have raised \$218,000 in pledges and donations.

Bob Tougher stated he appreciates the generous pledges; noting the Friends of Abenaki has shown a considerable amount of reliability. He stated he feels the lodge is the right fit.

Harold Parker stated he worked at Waterville Valley last year and heard a lot of positive feedback regarding the operations at Abenaki.

Article I Town Asset Management Program; \$50,000

Dave Ford stated the intent is to inventory all buildings and facilities including equipment, docks, parks and recreation and parking lots.

Frank Giebutowski asked if the program is technology based and who would do the work.

Dave Ford stated he received a free software program from EPA and Woodard and Curran would be the Town's consultant. He noted a Town employee would be trained to maintain the inventory.

Bob Tougher stated he is in favor of the request.

Article J Libby Museum Repairs; \$200,000

Dave Ford stated the article addresses the construction of required repairs related to the failing ceiling, excessive moisture problems and significant structural issues.

Article L Dockside Parking Lot Upgrades; \$124,000

Dave Ford stated the existing parking lot has many sinkholes and the best way to fix the issue is to reclaim the existing pavement, fill in the voids and create a separation between the fill and the parking gravel base using appropriate construction fabric. He stated the proposal includes parking lot upgrades, stormwater treatment and the creation of additional public space (loss of 10 parking spaces). He stated the article construction of the improvements will be contingent upon further appropriation of grant funding commitment from NHDOT (80/20 grant).

John MacDonald questioned the total cost of the project.

Dave Ford replied \$500,000; noting the amount required by the Town is 20%.

Harold Parker expressed concern for the loss of parking spaces.

Article M Wastewater Effluent Disposal Study; \$700,000

Dave Ford stated the purpose of the article is to study the Town's options relative to its treated effluent disposal. He stated the study would include developing and implementing pilot tests on alternative disposal methods and to continue inflow and infiltration studies, as agreed to with NHDES.

Article P Wastewater Treatment Plant Capital Reserve Account; \$125,000

Dave Ford stated he is proposing the replacement of the sludge storage building and sludge pumps, the addition of a supernatant tank and pump, new odor control equipment and repaving of the site.

Article R Public Works Vehicle and Equipment Capital Reserve Account; \$170,000

Dave Ford stated the article is related to the ongoing Highway and Solid Waste vehicle and equipment replacement program and is proposing the replacement of HD-9.

It was moved by Harold Parker and seconded by Bob Tougher to adjourn the December 18, 2014 Budget Committee meeting. All members voted in favor.

There being no further business before the Committee, the meeting adjourned at 8:32 PM.
