### Consideration of Minutes January 11, 2011

It was moved by Denise Roy-Palmer and seconded by Mike Cooper to approve the January 11, 2011

#### **Discussion Items**

#### > Review of tasks and assignments

Information re: "showcase" in Laconia (open house of available rental space in the town) Mary Devries stated she spoke to Kevin Sullivan, Realtor, who spear headed the event. She stated the event was a fantastic networking event, scheduled for 2 hours, lunch served, SBD and banks present. She recommended the EDC formulate and promote a similiar event. She recommended advertising available commercial real estate and questioned whether the event should be a physical open house event or a virtual open house.

Mary DeVries & Dave Tower to develop a plan for such.

#### **Inventory vacant commercial space**

Denise Roy-Palmer reviewed the number of for sale and for rent/lease properties available; noting a price range of \$129,000 - \$2 million.

Tony Triolo noted supply is not the problem.

# Develop questionnaire for Implementation of Visitation Business Program or development of focus groups

Gene Leone stated he and Dave Tower do not believe a survey of businesses would be productive and questioned what would be gained by such. He stated he is unsure if the Town has the political will.

Frank Giebutowski stated the Business Visitation Program is a huge effort with minimal return.

Referencing Meredith and Laconia, Dave Tower stated revitalization came from the business community and not government. He stated there needs to be an effort to understand the challenges; noting a general discussion for such.

Gene Leone stated the original Master Plan did not include development for the Back Bay area; noting the area grew regardless and grew as a result of the community and not government.

Mike Cooper stated the best place for economic development is with the current business community; recommending improvement of what currently exists rather than trying to add to it. He stated he is opposed to a Business Visitation Program and recommended that if the Committee engages in focus groups the Committee partner with the Chamber of Commerce's EDC.
