

**Wolfeboro Police Commission
Meeting Minutes
September 18, 2014**

Members present: Chairman Joe Balboni Jr. and Ron Goodgame.

Staff present: Chief Stu Chase, Captain Dean Rondeau and Recording Secretary Amelia Capone-Muccio.

Chairman Balboni called the meeting to order at 4:00 PM and introduced the Commissioner's, staff in attendance and noted a quorum was present.

Consideration of Minutes

- ***Public minutes of August 21, 2014***

Commissioner Ron Goodgame moved the Wolfeboro Police Commission to accept the public minutes of August 21, 2014 as submitted. Commissioner Joe Balboni Jr. seconded. Members voted and being none opposed, the motion passed.

Activity Reports

Chief Chase reviewed the following activity reports for the month:

Offenses (State Law) by month: He reported 92 offenses for the month, a 2% decrease from last month. He reported 558 offenses to date.

Arrest status report: He reported 233 arrests year to date. He reported 28 arrests for last month.

Personnel Analysis report: The report is a synopsis of each officer's reporting for the month.

Accidents by street name: He reported 16 accidents for last month and a 14% decrease from the previous year.

Prosecutor's report: He reported 21 defendants answering to 35 offenses, with 9 arraignments, 17 pleas, and 5 trials. \$ 7,836.00 was received in fines, fees or other assessments.

School Resource Officer (SRO): n/a.

Citation Report: He reported 230 citation stops last month with a majority of those on Center Street, North and South Main Streets. He noted they have been policing a common area for complaints on Beach Pond Road.
